Port Net

Port-Net is an Interreg IIIc Network project with 20 partners from 12 European countries and Russia. Its objective is to identify and tackle the main challenges faced by European ports in order to create better operational structures and capacities and achieve the best possible regional integration of ports. These targets continue to be achieved through workshops, lectures and best practice tours like this one. Previous workshops have taken place in Italy, Latvia, Poland, the Netherlands, Germany and Belgium.

Three components group the activities by topics. The first component deals mainly with the application and further development of EU policies. These workshops fall under the second component which deals mainly with improvements to the multi-modal transport structure as well as maritime cargo challenges. The final component focuses on tourism and urban development from a port perspective.

Lead partner of Port-Net is the Free and Hanseatic City of Hamburg but a democratic network structure guarantees equal involvement and a proper consideration of the interests of all partners. Project co-ordination is executed by Uniconsult, a port and transport consultancy from Hamburg.

As the UK's largest ports group, **Associated British Ports (ABP)** handles about a quarter of the country's seaborne trade, with 21 ports around the UK. Of those, 11 are short-sea ports, including the Port of Ipswich which is located at

the head of the River Orwell. Being 19 kms from the open sea, the Port of Ipswich is within a short sailing time of the principal North Sea shipping lanes. It has direct rail and excellent road links, allowing easy and fast transportation of goods to destinations throughout the UK, and prides itself on being able to provide a 'one-stop-shop' for a range of specialist port-related services.

The Port of Felixstowe is the largest containerport in the UK and the fourth largest in Europe, and stands 16th in the world rankings. Each year the port handles approximately 2.8 million TEU, more than 40 per cent of all containers entering or leaving the UK. In addition to container traffic, the port is a major roll-on/roll-off port, accommodating freight ferries from Europe, and has extensive warehousing operations.



Harwich International Port

is a modern, multipurpose port, strategically positioned on the East Coast of the UK. It is a natural gateway for passengers and freight to and from mainland Europe, Scandinavia and beyond. Set in 258 acres, the port has extensive handling facilities for ferry, cruise, container, ro-ro, bulk and general cargo traffic.



Harwich International Port

As a smaller member of the cluster of Haven ports, **Mistley Port** can offer services that the big boys cannot cater for but which complement the deep sea operations of the bigger ports, e.g. devanning at its own warehouse, sometimes for repacking and onward distribution.
